## FINANCE & EXPENDITURE CIRCULAR NO. 4. 2009

Vide order No.F.72(48)/Secy./DDA/87/II/Pt. dated 14:09,1990 issued by Secretary, DDA, the officers of the DDA who have been provided with staff vehicles/cars were allowed to use the same for to and fro journey from office to residence on payment of Rs.50/- per month.

Subsequent to implementation of 5th Central Pay Commission, no Transport Allowance has been allowed to the officers who have been allotted staff vehicles/cars/taxis. As such para-(iv) of the above said orders dated 14.09.1990 regarding use of staff vehicles/cars/taxis for to and fro journey from office to residence on payment of Rs.50/- per month is withdrawn.

After implementation of 6th CPC, Transport Allowance has also been allowed to the officers and as such, no Transport Allowance will be admissible to those officers who have been provided with the facility of staff vehicles/ cars/taxis and are performing to and fro journey from office to residence.

These orders will take effect from 01.08.1997 i.e. the date of introduction of Transport Allowance subsequent to implementation of 5th Central Pay Commission.
