- 2. In the case of Consultants (other than retired Officers) appointed before 01.01.2017, the remuneration will be fixed as per column (f) of above Table. The remuneration of Consultants (other the retired Officers) irrespective of date of appointment will be enhanced by 7.5% w.e.f. 01.04.2018 onwards on the pay fixed/paid on 01.07.2017.
- 3. The remuneration of the Consultant AAOs appointed in June July, 2017 has been enhanced from Rs. 35,000/- to Rs. 40,000/- per month and will take effect from 1st August, 2017. Their remuneration will be enhanced by 7.5% w.e.f. 01.04.2018 onwards as para-2 above on the pay fixed on 01.07.2017.
