F&E Circular No.8-A/2015

In partial modification of F&E Circular No. 28/2013 dated 18.12.2013, the Vice Chairman, DDA in exercise of powers vested in him vide Authority Resolution No.208 dated 25.02.1967, has been pleased to revise the Delegation of Powers for sanction of Honorarium to the following Officers of DDA under FR-46(b) as under:-

S.No.	Authority	Existing Powers	Revised powers
1.	Vice- Chairman	Full powers upto Rs. 4000/- in each case in a financial year.	Full powers upto Rs. 4000/- in normal cases and additional Rs.1000/- as a special incentive in a financial year
2.	Finance Member/ Engineer Member	Full powers upto Rs. 3000/- in each case in a financial year.	Full powers upto Rs. 3000/- in normal cases and additional Rs.1000/- as a specimentive in a financial year

Note:- 1. An individual employee shall not be paid more than Rs. 5000/- in total in a financial year in the form of Honorarium/incentive /reward.

- 2. The incentive and reward shall be treated as Honorarium.
- The financial powers for sanction of honorarium delegated to other officers will remain unchanged.
- Contractual staff and other daily rated staff/consultants will not be entitled for the enhanced honorarium in the shape of special incentive/reward.
- These powers shall be exercised by the officers subject to the conditions that budget provisions exists for meeting the proposed expenditure with due regard to any restrictions, scales or limits as are prescribed by Govt. in this behalf in GFRs, Delegation of Financial Powers Rules, FR & SR and other orders issued from time to time.
- However, other terms & conditions contained in F&E Office Order No. FE.16(35)/90/1770 dated 19.12.1990 shall remain unchanged.

These orders shall be effective from the date of issue of orders.
