Sub: Regarding conversion of proposed Petrol Pump site at Plot no. 22, Sector A-7, Narela into CNG site.

Synopsis

Two sites has been proposed for Petrol Pump at Plot no 4 and Plot no.22 in FC-2 at Sector A-7, Narela based on the request from IGL for allotment of land for CNG Station in FC-2, Sector A-7, Narela. The matter was examined and it was decided to convert one of the proposed site at plot no.22 from Petrol Pump to CNG filling station.

1.0 Background:-

Two sites have been proposed for Petrol Pump at Plot no.4 and Plot no.22 in FC-2 at Sector A-7, Narela based on the request from IGL for allotment of land for CNG Station in FC-2, Sector A-7, Narela. The matter was examined, a meeting was also held on 9<sup>th</sup> March 2010 in the chamber of Chief Secy., Delhi Govt. GNCTD regarding allotment of new CNG site and it was decided to convert one of the proposed site at plot no.22 from Petrol Pump to CNG filling stations as per minutes no. SO/CS/1506-1520 dated 12/3/10. The land status has already been given by Lands branch vide letter no. F.13(18)09CLPP/CNG/1008 dated.11/6/10.

2.0 Examination:-

2.1 As per approved layout plan of Sector A-7 (PSP area) two sites measuring (36x30M) have been proposed for petrol pump at Plot no.4 and Plot no.22. (copy enclosed)

2.2 As per MPD-2021 provisions one site of Petrol Pump and one CNG Station could be proposed in Public & Semi Public (PSP) area.

3.0 Proposal:-

Based on the above examination, one site of Petrol Pumps at plot no.22 could be converted to CNG site.

4.0 Recommendation:-

Proposal is submitted for consideration and decision of Screening Committee.

5.0 Financial Liability/Social Gain:-

The proposal will add to the facilities of this area for local Population.

6.0 Follow Up action

After the approval of Screening Committee, the modified L.O.P. will be referred to Engineering Wing, LD wing, LM wing for feasibility and demarcation, allotment and verification of Land status as per procedure.
