Synopsis

A request of Education Deptt., MCD, Narela Zone was forwarded by Institutional Branch, DDA vide file no. F.17(4)09/IL for the allotment of land for Primary School in pocket 3, sector A-9, Narela.

1.0 Background:

The request of MCD for allotment of land for Primary School in Sector-A-9, Pocket-3, Narela was forwarded by Institutional Land Branch in file no. F.17(4)09/IL was examined as per MPD 2021. The matter was put up in the 299th Screening Committee meeting held on 2/6/11. Decision of Screening Committee is as reproduced below:

" It was decided by the Screening Committee that the Primary School Site be earmarked with 2000 Sqm and two plots be carved out for Night Shelters. The Layout Plan showing the sub-division be put up again in the Screening Committee". 2.0 Examination:-

- As per MPD-2021 provisions, the plot area of primary school is 2000-4000 i)
- ii) As per the approved layout plan of Sector A-9 the site under reference is proposed for primary school/nursery school for an area measuring 4,700 Sqm.
- As per survey report, the available area is 4385 Sq.mt. as part of the area as 315 Sq.mt. approx. is under encroachment as shown on the copy of the plan.
