

## TO DWARKA




THE PROPOSAL WAS DISCUSSED IN THE 307th SCREENING COMMITTEE MEETING HELD ON 02.08.2012 VIDE ITEM NO. 62:2012 AND IT WAS DECIDED THAT THE PROPOSAL BE PUT UP IN SCREENING COMMITTEE AGAIN WITH THE FOLLOWING MODIFICATIONS:

- THE ALLOTMENT OF ESI PLOT BE CANCELED BY THE CLD AND THE PLOT BE MERGED WITH THE HOSPITAL PLOT.
- THE CSC PLOT BE RESIZED WITH AN AREA 1000 SQ.M. OR ABOVE ABUTTING THE HOSPITAL PLOT. IN THE CSC, NO REPAIR SHOPS FOR AUTOMOBILES WILL BE ALLOWED.
- THE PLOT OF POLICE POST WITH AN AREA OF 1000SQ.M. BE SHIFTED TO CORNER.
- AREA OF POLICE POST HAS BEEN REDUCED FROM 1600.80 SQ.MTS TO 1000 SQ. MTS. AND SHIFTED CORNER NEAR SEWAGE PUMPING STATION.
- ESI DISPENSARY ALLOTMENT CANCELLED BY I.L. DEPTT. LETTER NO. F- 33(1)90/IL/Pt DATED 28/9/12 & MERGED WITH HOSPITAL PLOT.
- POST OFFICE & SERVICE ACTIVITIES TO BE ACCOMODATED IN CSC MEASURING 1000SQ.MTS.
