NOTICE INVITING TENDER TO PRE-QUALIFY

The Executive Engineer, Rohini Project Divn.I, DDA Office Complex, Deepali Chowk, Sector-3, Rohini, Delhi - 110085, on behalf of the Delhi Development Authority re-invites pre-qualification application from firms/contractors of the repute for the following works :

2. Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.
 - (a) Should have completed three works (at least one of them in Central Government/Central Autonomous Body/Central PSU) each costing Rs. 4.60 crore or two work each costing Rs. 5.75 crore or one work costing Rs. 9.20 crore of the following nature during the last seven years ending last day of the month.
Construction of Drains in brick work or RCC box drains and RCC box culverts.
 - (b) Should have average annual turn over of Rs. 3.45 crore on construction works for the last three years ending 31st March 2004.
 - (c) Should not have incurred any loss in more than two years during the last five years ending 31st March 2004.
 - (d) Should have a solvency of Rs. 4.60 crore.
3. Desirous contractors may obtain pre-qualification document on request in writing from Executive Engineer, Rohini Project Divn. I, DDA Office Complex, Deepali Chowk, Sector-3, Rohini, Delhi-85 on payment of Rs. 250/- in cash, upto 3.30 PM on 18.03.2005.
4. Application for pre-qualification supported by prescribed annexures should be submitted in sealed envelope duly superscribed with the name of work and due date of opening. The applications will be received upto 3.00 P.M. on 21.03.05 and will be opened by the Executive Engineer or his authorised representative in his office on the same day at 3.30 P.M.
5. If any information furnished by the applicant is found incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of work in DDA.
The department reserves the right to verify the particulars furnished by the applicant independently.
6. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic PQ criteria.
7. The cost of respective works completed by an Agency shall be suitably enhanced @ 5% for each subsequent year following the financial year in which that particular work had been completed to bring it at par with the present cost. Enhancement on similar lines shall also be effected in respect of turnover of the agencies.
