Please refer to your application dated 7/3/2 regarding booking of vacant land for temporary use to hold religious/social/marriage. - The said booking for temporary use permitted above shall not be misused for any other purpose. If any misuse is found at site, the land shall be vacated with force without any notice in this record and DDA shall not be responsible for any damage or loss on this account. In such eventuality, your security deposit shall stand forfeited.
  - 2. The said land shall also be evicted forcibly at your risk and cost if more land is encroached then permitted above or more than the permitted days as above. Under such circumstances, DDA shall not be responsible for any damages or losses to your moveable properties. Your security deposit shall also be forfeited under such circumstances.
  - 3. The proxy booking is not allowed.
