Five posts of Chief Engineers (Civil) in Pay Band –IV of Rs.37400-67000/- with Grade Pay Rs.10,000/- are proposed to be filled up on deputation basis. The eligibility conditions for deputation are as under:

- 1) The candidate should be holding analogous post; or of the rank of Superintending Engineer or equivalent in Grade Pay Rs.7600/- or in Rs.8700/- with 7 years' service in the grade; and
- 2) Should possess Degree in Civil Engineering from a recognized University or equivalent.
- 3) 12 years experience in a supervisory capacity of design and execution of work including construction of roads, buildings, bridges, laying of water supply, drainage and sewerage works.
- 4) The period of deputation shall not ordinarily exceed three years.
