The eligibility criteria for appearing in DDA Accounts Service Examination is as under:-

- (A) Pre-liminary Examination
- (i) Assistants/UDCs/Stenographers having three years regular service.
- (ii) Graduate LDCs having three years regular service.
- (B) Part-I Examination

The candidates who have qualified pre-liminary Examination.

- (C) Part-II Examination
 - (i) The candidates who have passed DDA Accounts Service Part-I Examination,
 - (ii) The candidates who have got exemption in two subjects in Part-I Examination.

The Roll Numbers/ Index Numbers and Date Sheet of Examination shall be issued to the eligible candidate in due course of time by F&E Branch.
