All the original registration certificate/work completion certificate will be shown by the contractor at the time of sale of tender and the same should be scanned and uploaded at the time of online submission of tender.

(gross) value of work (duly audited by Chartered Accountant) on annualized basis (depending upon the time allowed for the completion i.e. total estimated value divided by time of completion).

  - iii. Three similar works each costing not less than 40% of the Estt. Cost (gross) of the proposed work.
