NOTICE INVITING TENDER No. 2/EE/RPD.8/DDA/2008-09

Sealed item rate tenders are invited for the following works by the Executive Engineer, Rohini Project Division No.8 D.D.A. Rohini, Delhi-85 upto 3.00 P.M. on 20.10.08 on behalf of Delhi Development Authority from the approved contractors of appropriate class of the Delhi Development Authority, M.E.S., C.P.W.D., P & T & Railway which shall be opened on the same day at 3.30 P.M. at Press building, Vikas Sadan, I.N.A. near I.N.A. market, New Delhi in the presence of the intending tenderers or their representatives.

The tender documents can be had from the tender sale counter at Vikas Sadan, Press Building, I.N.A. Market, New Delhi on any working day between 10.00 A.M. to 3.00 P.M. on payment of tender cost as mentioned against the work (non-refundable) on production of valid I.T.C.C. Registration Certificate and Sale Tax registration in original. The issue of tender forms shall be stopped on 17.10.08 at 3.00 P.M. Original I.T.C.C. & Registration Certificate & Sales Tax Registration will be shown by the contractor at the time of sale of tender.

The tender will be sold to those contractors who will deposit the earnest money alongwith tender application. The earnest money shall be in the form of a cash deposit receipt for demand draft of a schedule Bank Guaranteed by the Reserve Bank of India in favour of Sr. A.O. (CAW) Rohini. The earnest money may also be deposited in the form of a F.D.R. which should be pledged in favour of E.E./R.P.D.8, D.D.A. and should be valid for at least six months after the last date fixed for receipt of tenders. The application of tender of the contractor who does not enclose the earnest money with prescribed manner shall be summarily be rejected.

The tenderer whose tender is decided to be accepted by the Competent Authority, shall be required to submit performance Guarantee equal to 5% of the tendered amount in the prescribed form in accordance with clause 1-A of the conditions of contract mentioned in N.I.T. within 15 days from the issue of letter of intent failing which, the earnest money deposited by him/them shall be forfeited absolutely. Other terms and conditions of PWD.6 shall remain unchanged.
