This is to certify that application of date 17/10/11 regarding booking of vacant land for religious use to hold religious marriage function at the C Hall N. Block - Jalandhar is hereby granted for the period of 04/01/12 to 05/01/12. The land is situated at C Hall N. Block - Jalandhar. The area of the land is 2186 sq. ft. The booking is valid from 04/01/12 to 05/01/12. The booking is subject to the conditions mentioned below.

- The said booking for temporary use of land shall not be misused for any other purpose. If any misuse is found, the land shall be vacated with force without any notice. The booking authority shall not be responsible for any damage or loss or injury to the property or the security deposit shall stand forfeited.
- The said land shall also be vacated if any risk and cost if more land is encroached then permitted above. Under such circumstances, IDDA shall not be responsible for any damages or losses to your moveable properties. The security deposit shall also be forfeited under such circumstances.
- The booking is not allowed if any complaint is received by the field staff of IDDA that temporary booking has been granted without representing the facts, and is practicing any fraud and or the booking authority. The permission so granted shall automatically stand cancelled. The booking authority will be liable for eviction forcibly. Besides criminal proceedings in respect of your security deposit, IDDA shall not be liable for any damage and or loss or injury to your during such forcible eviction.
- It must that on IDDA's property such as boundary wall, grill fencing, gates, roads & ways etc. is damaged. In case of any damage in this regard your security shall stand forfeited to satisfy the cost of the repair damage.


5. You will be liable to ensure the safety means provided by the Chief Fire Officer. No DDA liability shall be incurred in the event of any fire accident or other cause due to your staff's carelessness or other negligence. Copy on file.
6. No parking vehicles away from the DDA premises shall be allowed.
7. You will have to make your own arrangements for water, electricity etc.
8. Use of loud sound speakers, etc. Musical instruments and band etc. is subject to various Acts/Laws in force and you will have to get permission where it required from the authority concerned.
9. In case the booking is cancelled due to any reason by you and the intimation of this cancellation is made before one month from the date of function you shall be entitled for 90% and 50% refund if intimation is made before 15 days of function. No refund shall be allowed if the intimation is within the 15 days from the date of function. Such refund shall be allowed only on properly documented requests and these orders shall be applicable with prospective effect.
10. Booking as permitted above is non-transferable. In case of unauthorized transfer of booking is detected by field staff of DDA, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions besides eviction and forfeiture of security deposit.
11. DDA reserves the right to cancel the said permission without any notice in case of violation of the said terms and conditions.
12. DDA also reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.
