Sub: Permission for temporary use of vacant land area Rs. 200/- sq
mts. On date 3/10/11 to 4/11/11, for religious social/marriage function at
site Sector 6 DDA Site - 4

Sir/Madam:

Please refer to your application dated 26/9/11 regarding booking of vacant land for temporary use to hold religious social marriage. You are hereby granted permission to hold religious social marriage function in account of DDA's land at Sector 6 DDA Site - 4 measuring 800 sq mts on 3/10/11 to 4/11/11 for temporary use on the following conditions as already discussed by you.

1. The said booking for temporary use of vacant land shall not be utilised for any other purpose. If any misuse is found at site the land shall be vacated with fees without any notice to the user and DDA shall not be responsible for any damage or loss on that account. In such a liability, your security deposit shall stand forfeited.
2. The said land shall also be evicted based on your rate and cost if more land is encroached then permitted above area within the permitted days as above. Under such circumstances, DDA shall not be liable for any damages or losses to your moveable properties. Your security deposit shall also be forfeited under such circumstances.
3. The plaza booking is not allowed. If it is found by the filed staff of DDA that temporary booking has been granted to you misrepresenting the facts, and/or practising any fraud and/or giving impersonation, the permission so granted shall automatically stand annulled and you will be able for eviction forcible besides criminal proceeding. In case of non-recovery of your security deposit, DDA shall not be liable for any damage and/or losses sustainable to you during such forcible eviction.
4. It must that on DDA's property such as boundary wall, grill fencing, gates, roads & trees etc. is damaged. In case of any damage in this regard your security shall stand forfeited besides recovery of the value damage.

10. In case you do not want to be liable to the Chief Fire Officer or DWDIA, then you have to take care and be committed under your due to your State Government or your Municipality or Corporation.

11. If you do not book through us, then you have to take care of your local area to obtain a booking ticket from the concerned authority like, Panchayat, Gram Sabha, etc. All local governments and Board etc. accept no bookings. Let's laws in force and you will have to get permission where it is required from the authority concerned.

12. In case the booking is cancelled due to any reason by you and the intimation of that cancellation is made before one month from the date of function you shall be entitled for 90% and 50% refund if cancellation is made before 15 days of function. No refund shall be claimed if the cancellation is within the 15 days from the date of function. Such refund shall be allowed only on properly manifested basis and these rules shall be applicable with prospective effect.

13. Booking as permitted above is non-transferable. In case of unauthorized transfer of booking is detected by staff of DWDIA, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions besides cancellation and forfeiture of security deposit.

14. It is also to be noted that you can't cancel any booking in case of violation of the rules terms and conditions.

15. DWDIA reserves the right to withdraw permission under forced circumstances without any liability on account of damage and losses from your side.
