**E-TENDER NOTICE**

Online Sealed Item Rate tenders are invited through E-tendering mode for the following work by the Ex. Engineer/ND-9/DDA on behalf of the DDA upto 3.00 P.M. on (mentioned below) from the approved and eligible contractors of appropriate class of the DDA and CPWD and those appropriate list of MES, BSNL and Railway which shall be opened on the same day at 3.30 P.M. through e-tendering mode.

Earnest money and cost of tender shall be deposited through separate transaction through RTGS/NEFT in the account of Sr. A.O./CAU/NZ having account No. 0637000100356153 with Punjab National Bank, Ashok Vihar branch (IFSC code RTGS/NEFTIFSC Code PUNB 0063700). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened.

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money up to Rs. 20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EM is more than Rs. 20.00 lacs then the amount of EM beyond Rs. 20.00 lacs can be deposited in the form of Bank Guarantee also such Bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.

The Unique transaction reference of RTGS/NEFT against EM Cost of tender document and Bank Guarantee shall be placed in single sealed envelope superscripted as "Earnest Money Cost of Tender Documents" with name of work and due date of opening of the bid mentioned thereon and will submit to tender opening Authority as mentioned against each work.

Copy of Enlistment Order and certificate of work experience as required shall be scanned and uploaded to the e-tendering website within the period of tender submission and certified copy of each shall be deposited in a separate envelop marked as, "Other Documents".

Both the envelopes shall be placed in another envelope with due mention of Name of work, date & time of opening of tenders and to be submitted in the office of Executive Engineer during the period mentioned above.

Online tender documents submitted by intending bidders shall be opened only of those bidders, whose Earnest Money Deposit, Cost of Tender Document and e-Tender

Processing Fee and other documents placed in the envelope are found in order.
