INFORMATION

Please refer to your application dated 27-8-12 re booking of  
vacant land for temporary use to hold religious/social/marriage. You are hereby granted  
permission to hold religious/social/marriage function on account of  
use of DDA's land at Chak 5-8 measuring 2820 sq.  
mts. on 28-11-12 to \_\_\_\_\_ for temporary use on the  
following terms & conditions as already accepted by you.

1. The said booking for temporary use permitted above shall not be misused for any other purpose. If any damage is found in site, the land shall be vacated with force without any notice but DDA shall not be responsible for any damage or loss in this regard. In such eventuality, your security deposit shall stand forfeited.

2. The said booking shall be for \_\_\_\_\_ days. In case if more land is required than permitted above, \_\_\_\_\_ the permitted days as above, under such circumstances DDA shall not be responsible for any damages or loss to your movable properties. Your security deposit shall also be forfeited for such circumstances.

3. The above booking is not a lease. In case it is found by the Head of DDA that temporary booking has been obtained by you misrepresenting the facts, and/or through my fraud and/or through impersonation, the permission so granted shall automatically stand cancelled and you will be liable for eviction forcibly, subject to criminal proceeding or forfeiture of your security deposit. DDA shall not be liable for any damage and/or losses sustained to your during such forcible evictions.

4. It must be kept in mind that the property is enclosed in a boundary wall, grill fencing, gates, roads and other structures. Damage to any of these in this regard your security shall stand forfeited besides recovery of the same damage.

(i) You will have to ensure the fire norms prescribed by the Chief Fire Officer, GNCTD, you shall have no responsibility of any fire accident or otherwise due to your carelessness or sheer negligence. (Copy enclosed).

(ii) Parking vehicles inside the DDA's vacant land is allowed.

(iii) You shall have to make your own arrangement for water, electricity etc.

(iv) All land, loud speakers, DJ's Musical instruments and Bands etc. is subject to various permissions in force and you will have to get permission where if required from the authority concerned.

In case the booking is cancelled due to any reason by you and the intimation of cancellation is made before one month from the date of booking you shall be entitled for 30% refund if intimation is made before 15 days of function. No refund shall be allowed if the intimation is within 15 days from the date of function. Such refund shall be allowed only on proper diary's & tests and these orders shall be applicable with prospective effect.

Booking as permitted above is non-transferrable. In case of unauthorized transfer booking is defected by field staff of DDA, both the parties i.e. unauthorized transfer and licensee shall be liable for penal actions besides eviction and deduction of security deposit.

(v) DDA reserves the right to cancel the valid permission without any notice in case of violation of the said terms and conditions.

(vi) DDA reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.

(vii) In case of the loss, damage, theft received with the booking, it shall be compensated by DDA by obtaining the evidence concerned, the same with the approval of Competent Authority.
