Please refer to your application dated 31-08-12 regarding booking of vacant land for temporary use to held religious social/marriage. You are hereby granted permission to be religious/social marriage function on account of use DDA's land

As Above measuring 100 sq. M²
 On 26.08.12 to 30.08.12 for temporary use on following terms & conditions as already accepted by you

The said booking for temporary use permitted above shall not be misused for any other purpose. If any misuse is found at site the land shall be vacated with force without any notice given and DDA shall not be responsible for any damage or loss on this account. Such criminality your security deposit shall stand forfeited.

The said land shall also be vacated forcible at your risk and cost if more time is encroached than permitted above or more than the mentioned days as peruse. Under such circumstance DDA shall not be responsible for any damages or losses to your moveable properties. You won't be able to sue DDA for any damage or loss sustained due to such instances.

The present booking is non-renewable. In case it is found by the field staff of DDA that temporary booking is being misused, or holding an unauthorized function, and/or practicing any fraudulent/irregular operation, the permission so granted shall automatically stand cancell and you will be liable for action/case. Besides criminal proceeding, if any, on forfeiture of your security deposit DDA shall not be liable for any damage and/or losses sustainable to you during such forcible eviction.

I certify that my DDA experience begin from boundary wall, grill fencing, gates roads and trees etc. I am fully aware of the consequences of this notice your security shall stand forfeited in case of any of the above clauses.

5. You will have to ensure the fire norms prescribed by the Chief Fire Officer GNCID, DDA shall have no responsibility of any fire accident or other-wise due to your starkness, carelessness or sheer negligence. (copy enclosed).
 6. No parking vehicle inside the DDA's vacant land is allowed.
 7. You will have to make your own arrangement for water, electricity etc.
 8. Use of land load speakers, DJ'S Musical instruments and Band etc. is subject to various Acts/Laws in force and you will have to get permission where it required from the authority concerned.
 9. In case the booking is cancelled due to any reason by you and the intimation of this cancellation is made before one month from the date of function you shall be entitled for 90% and 50% refund if intimation is made before 15 days of function. No refund shall be allowed if the intimation is within 15 days from the date of function. Such refund shall be allowed only on properly diaries requests and these orders shall be applicable with prospective effect.
 10. Booking as permitted above is non-transferable. In case of unauthorized transfer of booking is detected by field staff of DDA, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions/besides eviction and forfeiture of security deposit.
 11. DDA reserves the right to cancel the said permission without any notice in case of violation of the said term and conditions.
 12. DDA also reserves the right to withdrawn permission under forced circumstances without any liability or claim of damages and losses from your side.
 13. If the rates of booking/charge revised upto the date of function the applicant is liable to deposit the increased amount.
