

TERMS & CONDITIONS :-

1. All material used at site shall be got approved before fixing at site from J.E (Civil) / Secretary (RSKP).
2. Prices quoted shall be firm and inclusive of all Taxes.
3. The payment will be made after entire satisfaction of Secretary (RSKP) / J.E.(Civil) DDA.
4. No T&P will be issued by Department.
5. No advance payment will be made to the agency.
6. No minor shall be engaged at site.
7. Nothing extra will be paid to the agency by the Deptt.
8. The quotation can be rejected without assigning any reason by the competent authority.
9. The work can be terminated at any time without giving any reason and notice.
10. Conditional quotation will not be accepted.
11. Necessary statutory deductions as applicable will be made.

12. The Agency should be registered with Trade & Taxes Deptt., GNCTD of Delhi & supposed to furnish a copy of Sales Tax Registration (W.C. Cell) & W.C. Clearance Certificate and attach the same along with the quotation otherwise the quotation may not be considered and liable to be rejected.
13. Debarred agency/or individual shall not be permitted to participate in the tendering process.
